# شركة العاشر من رمضان للصناعات الدوائية والمستحضرات التشخيصية «راميدا» ش.م.م تعلن بدء التداول على أسهمها بالبورصة المصرية

## القاهرة في ١١ ديسمبر ٢٠١٩

أعلنت اليوم شركة العاشر من رمضان للصناعات الدوائية والمستحضرات التشخيصية (راميدا) ش.م.م. (ويشار إليها بمصطلح "الشركة"، أو "راميدا" أو "المجموعة" في حالة الإشارة إليها وشركاتها التابعة بصورة مجمعة)، وهي شركة رائدة في قطاع الأدوية بالسوق المصري، عن بدء التداول على أسهم الشركة بالبورصة المصرية تحت رمز (RMDA.CA) مع افتتاح جلسة التداول في تمام الساعة الماشرة من صباح اليوم الأربعاء الموافق ١١ ديسمبر ٢٠١٩ بسعر ٤,٦٦ جنيه للسهم ("سعر الطرح").

ويبدأ التداول بعد إتمام عملية الطرح التي شهدت قيام المساهم الرئيسي شركة «Greville Investing Ltd» ("المساهم البائع")، بطرح عدد ٣٥٧,٧٧٥,٧٠، وعدد ١٨,٨٣٠,٣٠٠ وعدد ١٨,٨٣٠,٣٠٠ سهم لشريحة الطرح الخاص للمؤسسات المالية والمستثمرين المؤهلين ("الطرح الدولي")، وعدد ١٨,٨٣٠,٣٠٠ سهم لشريحة المستثمرين الأفراد في السوق المصري ("الطرح العام").

وقد قامت الشركة بتكليف كل من مؤسسة «HSBC Bank plc» ومؤسسة «Investec Bank plc» بدور المنسق العالمي ومدير الطرح المشترك، بينما تقوم شركة «سي أي كابيتال لترويج وتغطية الاكتتابات في الأوراق المالية» بدور مدير الطرح المشترك، وتقوم شركة «كومباس كابيتال» بدور مستشار شئون الترويج لعملية الطرح. وتجدر الإشارة إلى أنه تم تكليف مؤسستي «HSBC Bank plc» و«Noestec Bank plc» بدور المنسق العالمي ومدير الطرح المشترك لشريحة الطرح الخاص فقط (الطرح الدولي).

ويبلغ رأس المال السوقي لشركة راميدا ٣,٦ مليار جنيه تقريبًا (حوالي ٢٢٢ مليون دولار) عند بداية التداول على أسهم الشركة.

جدير بالذكر أنه لمدة ٣٠ يومًا من تاريخ بدء التداول على أسهم الشركة بالبورصة المصرية ("مدة حساب دعم استقرار سعر السهم")، سيحق للمشترين في الطرح العام فقط راغبي البيع إيداع أو امر بيع بحد اقصى عدد الأسهم المخصصة لهم فقط من خلال الطرح العام، على أن تقوم «سي آي كابيتال» بإيداع أمر شراء مفتوح بسعر الطرح وذلك لمدة الـــ ٣٠ يوم المشار إليها. وفي نهاية مدة حساب دعم استقرار سعر السهم، سوف يتم تنفيذ كامل الأوامر المودعة من راغبي البيع والتي تنفق مع الشروط الواردة بنشرة الطرح بالبورصة المصرية.

وفي هذا السياق أعرب الدكتور عمرو مرسي الرئيس التنفيذي لشركة «راميدا»، عن اعتزازه بإتمام الطرح العام في البورصة المصرية وهو ما يعد بمثابة إنجاز جوهري بمسيرة نمو الشركة وأيضًا شهادة تقدير على تضافر جهود جميع الزملاء والقائمين على تنفيذ الطرح بنجاح. وأوضح مرسي أن الشركة بدأت منذ عام ٢٠١١ تطبيق استراتيجية توسعات طموحة مما أثمر عن ترسيخ مكانة راميدا بين أبرز شركات الأدوية وأسرعها نموًا في السوق المصري. وأضاف أن الإدارة تتطلع بعد إتمام الطرح العام إلى انطلاقة نمو جديدة تتبلور محاور ها الرئيسية في استحداث وإطلاق المزيد من المنتجات الدوائية الابتكارية لتغطية مختلف المجموعات الدوائية الرئيسية في مصر، بالإضافة إلى فتح أسواق تصديرية جديدة في إطار التوسعات المخططة على الساحة الدولية، وكذلك مواصلة تنفيذ التوسعات التشغيلية من خلال الاستحواذ على المستحضرات الدوائية الجديدة وأيضًا دراسة فرص الاستحواذ على شركات متخصصة في إنتاج المستحضرات الدوائية على الصعيدين المحلي والإقليمي. ولفت مرسي إلى أن التغطية القوية للطرح من جانب المستثمرين المحليين والدوليين يعكس ثقة مجتمع الاستثمار في قوة نموذج أعمال الشركة وفرص النمو الواعدة التي تحظى بها، مشراً إلى اعتزازه بالعمل على تعظيم العائد الاستثمار ي للمساهمين خلال المرحلة المقبلة.
